

- Specifically designed for places of worship, schools, community centers and other 501(c)(3) organizations




## The Challenge



- 2. Register for Required IDs
- 3. Identify the State Administrative Agency (SAA)

Phase 2: Risk Assessment & Justification (2-4 Weeks Before Deadline) 4. Conduct a Vulnerability/Risk Assessment 5. Complete the Investment Justification (IJ) Form 6. Get Quotes for Proposed Projects

Phase 3: Submit Application (1-2 Weeks Before Deadline) 7. Collect and Finalize All Documents 8. Submit to the SAA

Phase 4: Post-Submission & Next Steps 9. Wait for Award Notification 10. Prepare for Project Execution (If Funded) 11. Stay in Compliance
